1. Apologies for Absence: Cllr J Sloan

- 2. Declarations of Interest by Councillors on any items on the Agenda: None
- 3. Approval and signing of Minutes from the previous meeting on 27<sup>th</sup> January 2016. The contents of the minutes were approved as an accurate record. All agreed.

### 4. Vacancy on the Council

Email from Powys County Council advised that they have not received a request for an election therefore, in accordance with the Local Elections Rules (1986) the Council is now required to fill the vacancy by co-option. The Notice of co-option has been displayed on the notice board and on the Council website.

#### 5. Byelaws

On the advice from Powys County Council copies of Llandinam Byelaws have been forwarded to Wyn Richards at PCC, Colin Edwards - Principal Solicitor in Welshpool and Kerry Powell of Dyfed-Powys Police. The Council needs to display appropriate signs. Cllr C Owen offered to get prices.

#### 6. Play area

Stephen Gealy advised that he has asked PCC's Health & Safety Advisor to explain the CDM regulations in more detail and the legal position regarding CHAS registration. This additional information has now been received. The Community Council agreed to ask the Contractor to complete the Construction Phase Plan and re-quote for the equipment and the work, if necessary. Proposed by Cllr A Owen and seconded by Cllr R Davies. All agreed.

#### 7. Community Council car park

Unsatisfactory response has been received from Powys County Council regarding this matter. Clerk to chase again.

# 8. Cemetery.

Heavy duty refuse sacks have been purchased for the removal of rubbish from the cemetery.

It has been brought to the attention of the Chairman that the path leading from Minafon up to the church is overgrown and some of the railings are missing, which is a danger to the public. Clerk to contact Lord Davies.

### 9. Highways

Cllr C Owen advised that the litter bin on the side of Llandinam bridge has been removed. Clerk to contact Highways regarding the replacement.

He also commented on very poor road diversion signs for the recent level crossing closure. The signs lacked clear information for motorists which led to confusion and traffic chaos on alternative single track roads.

Cllr M Davies informed the Council that two out of three caravans in the passing place by Middle Esgair have now gone. He also expressed his concern about exceptionally unpleasant odours around Bryn Posteg Landfill Site area affecting the local residents. Cllr R Davies suggested contacting Potters Waste Management Group, the Environment Agency and the neighbouring councils.

Cllr M Jones brought to the attention of the Council the continuing problem of speeding through the village and the lack of signs or speed indicating devices. The bigger polite signs asking motorists to drive slowly through the village were discussed. Cllr C Owen offered to find out more information from One Voice Wales.

Cllr C Owen pointed out that as all planning consultations to town and community councils are now being sent electronically, the Council may decide to purchase an overhead projector at some point in the future.
