# 3. Appointments

Cllr Colin Owen thanked all Members for their support over the past 12 months.

**Election of Vice-Chairman**: Cllr Andrew Owen was elected as Vice-Chairman by 4 votes in favour.

**P/2010/0650,** Grid Ref. 303336.06/281337.35 for Full: Erection of nine wind turbines with a maximum height to blade tip of 125m, a permanent sub station and compound, a permanent 80m meteorological must, borrow pits, transformer units, crane pads, cabling and the culverting of watercourses, access track construction, off-site highway works and temporary construction compound at land known as Hirddywel, 6.5km to south east of Llanidloes, Powys. A Supplementary Environmental Statement.

Cllr M Davies left the room when this application was discussed. The Community Council agreed to support this application with five votes in favour and one abstention.

Cllr M Brennan expressed his concern about members of the community not being able to comment due to an inadequate time allowed.
