- (a) Car Park
 - Toilet K&S have offered £200 for the purchase of the toilet ALL AGREED;

(c) Play Area

- Lottery funding for Playground works AO confirmed 3 quotes would be required for lottery funding application
- It was agreed that Phase 1 the replacement of the central piece of play equipment should be instructed as per the original tender in the sume of £49,973 + VAT
- Community Consultation for Phase 2 additional works Playground Committee to meet to agree how this process might be commenced, given the current situation regarding the Covid 19 pandemic;

(d) Highways

- Drain covers in the village some have been addressed on A470 trunk road;
 repairs to those on minor roads have not been prioritized for action by PCC.
- Hedge opposite Severn View has been cut back
- Mr Jones' hedge request sent for encroachment pruning to be undertaken.
 KL advised that Highways can insist on works being undertaken and recover any costs of the works being instigated if the landowner does not comply with request.

- The cracks remain an alternative to pointing (which might not look sympathetic) to be considered.
- Weed spray to be undertaken
- The rules relating to mass gatherings currently in place will affect Remembrance Services, however KL to source wreath to be laid on behalf of LCC.
